<b>Narcotic Preparations</b>  E.g. Fiorinal <sup>®</sup> -C¼, Fiorinal <sup>®</sup> -C½, Tylenol <sup>®</sup> No.2, Tylenol <sup>®</sup> No.3, Robitussin AC <sup>®</sup> , Dimetane Expectorant C <sup>®</sup> , 292 <sup>®</sup> , etc.  <b>Exempted Codeine Preparations</b> E.g. <b>Controlled Drugs Part I</b>  E.g. amphetamines, methylphenidate, dextroamphetamine, etc.  <b>Controlled Drug Preparations Part I</b> <i>(Currently none available in Canada)</i>	Drugs listed in Part I of Schedule to Part G of the <i>Food and Drug Regulations</i>  All products containing only 1 controlled drug ('straight' controlled drugs)  All combinations containing more than 1 controlled drug. Notes:

- Scanned original prescriptions and dispensing records must be retained as part of the Patient Record for 10 years from their last recorded professional pharmacy service or until 10 years after the day on which the patient reached or would have reached the age of 18 years, whichever is longer (DPRA regulations)

<sup>3</sup> Prescription and Dispensing Record Requirements are set out in the *Controlled Drugs and Substances Act* (CDSA), the *Food and Drugs Act* (FDA), the *Drug & Pharmacies Regulation Act* (DPRA) and the *Narcotics Safety & Awareness Act* (NSAA) and their respective regulations

<sup>4</sup> Per the NSAA, requirements apply to all controlled substances (as defined in the CDSA) and any drugs in the Monitored Drugs List as set out by the Ministry of Health and Long-term Care

<sup>5</sup> A logged prescription is a new, unfilled prescription that is entered into the patient record ('on hold') and may be dispensed at a later time

<sup>6</sup> Purchase & Sales Record requirements are set out in the CDSA and the Drug Interchangeability and Dispensing Fee Act (DIDFA) and their respective regulations
